Application Fees

\$300 for both days. Fees must accompany this application. We will not process any payment unless you are selected to participate in the event. This decision will be made by 5pm on April 1, 2025.

Booth Information

Booth space will be assigned by the event committee on a first-come, first-served basis. Assigned are one (1) booth space per application which includes a one (1) 8-foot table, and two (2) chairs. Vendor must supply their own 10x10 tent. All displays must fit within the 10x10 booth space. No materials, extension cords or electricity will be provided. Exhibitors are responsible for their own items throughout the event.

Parking and Set-up

Merchandise Vendors are not allowed to drive or park on the event grounds/grass. All vehicles must be parked in a legal parking spot and/or location.

Participation Criteria

Interested organizations must submit this application by March 14, 2025.

Decision is based on traditional/ethnic arts, quality craftsmanship, ethnicity and prior participation in the Skokie Festival of Cultures.

The selection committee reserves the right to reject any application which does not meet the criteria, conflicts with the Village of Skokie’s ordinances or are considered inappropriate for this event.
